The FSK insulation facing tape is coated with a flame retardant, acrylic adhesive. Available in silver, this tape provides a strong and secure bond on a variety of surfaces and textures, is mold resistant, and is UL 723 classified. An epoxy resin coating on the insulation tape helps protect the surface from corrosion caused by moisture.
